-Leti Barbetta called the meeting to order at 8:35 a.m.

-Leti called for a motion to approve the minutes of the September 16, 2008 meeting. The motion was made, seconded and approved by members present.

-Thank you to Amy Albrecht and the Back-to-School BBQ committee for all their hard work putting together such a fun event that was enjoyed by everyone.

-Thank you to Julia Venturino for leading the Kindergarten Parade.

-Thank you to all the parents who helped Picture Day run smoothly. Picture Day not only ran on time, we were over an hour ahead of schedule!

-Another thank you to Amy Albrecht for organizing the Fall Plant Sale. Our thanks also go to Caryn Quinn who teamed up with Amy to sell Halloween novelties.

-Thank you to our Safety Committee for making sure, rain or shine, our children are safe as they arrive and leave school each day.

- Laura Morea said that the Committee is still in need of volunteers 15 minutes before and 15 minutes after school each day.

**Treasurer's Report**

**Trish Otis**

Trish stated that the SCA's funds are very low right now. Fundraisers are going to be of critical importance to ensure that we are able to fund this year's budget. Committees should do everything they can to keep costs as low as possible. Last year at this time, the SCA had a balance of \$19,306.26 compared to this year's balance of \$5,707.90. Currently, we owe Jostens \$2,400 (yearbooks) and the accountant is owed \$1,000.

-The After School account has a balance of \$8,332.

The board would like to combine the SCA's accounts and just have one account. This would make it possible to borrow money from the After School account as we need it and then replace it when the money is raised. In fact, this may have to happen regarding the Fashion Show. We need to pay Leonard's \$6,507.50 eight weeks prior to the event.

-A parent asked if the \$5,707.90 balance includes money for the Circular Accounts. Trish said yes. The parent noted that at this point the actual balance is a negative balance when you consider everything that needs to be paid out. Trish agreed and said that it is very close to a negative balance. This is why we are asking the committees to try to keep their costs under budget whenever possible. Hopefully, the Fashion Show will bring in the revenue we need to run the programs the SCA runs. A parent said that the Fashion Show should not be the only fundraiser. We need to raise a lot of money--quickly.

-A board member responded that we discussed fundraising in our last Executive Board Meeting and that we do have other fundraising plans.

-A parent asked why there is \$8,000 in the After School account. Linda said that the SCA is a non-profit organization. A non-profit organization is supposed to spend the money in the year in which funds are raised in order to maintain non-profit status. By the end of the year we are supposed to have a balance that will be sufficient to get us through the first couple of months of the year. Two years ago, we had a very successful Fashion Show so we had a lot of money. In light of that, anything less than the large balances we are accustomed to seeing looks like failure when, in reality, it is not.

Checking 1 Actual web banking \$5,707.90

-Debits still outstanding \$1,000 (accountant fee) \$2,400 (yearbook fee)

Checking 2 Actual web balance \$8,332.05

-No bills or deposits outstanding at this time.

-Trish left the meeting at this time.

At this point, the discussion about the After School Program continued. Linda said that the way the program operates is that there is an initial outlay of money and then the parents pay for the courses that their children take. For this reason, we pretty much break even on this Program. The After School Program will not cost \$8,000 to run this year, and because we are non-profit, this money should be spent. The most that we would need at this time is \$3,000. We are asking the membership to authorize the Board to take the money from the After School Account. Linda asked that a motion be made.

-Andrea said that according to the minutes of the February 12, 2008 SCA Meeting, the board has already been authorized to maintain a balance of \$5,000 in the After School Account and that there was no need for a motion. She read from the minutes:

“Anna Sharkey suggested keeping a balance in the After School Account of \$5,000 to cover future start-up costs of running the SCA After School program.

-A motion was made to keep a minimum balance of \$5,000 in the After School account to cover future start-up costs of running the After School program. The motion was made, seconded and approved by members present.”

### **Co-President's Report:**

### **Leti Barbetta**

Leti said that we now have chairs and volunteers for every committee except the Citizen's Awareness Committee.

-The SCA held a special meeting on Friday, September 19<sup>th</sup> to discuss the Fashion Show/Night Out. Our co-chairs are Deana Roper, Terry Sheridan and Dawn Papiro. This fundraiser will be a hybrid of the traditional Fashion Show and last year's night out. The event will take place on April 23, 2009.

-The Spirit Committee is now taking pre-orders for GWL clothing. Please contact Deana Roper to order GWL Spirit wear including t-shirts, sweatshirts and hooded sweatshirts and sweatpants.

- Liz Falcone will chair the Fall Catalogue Sale. Please contact Liz to volunteer for this fundraiser.
- Next week, GWL will begin a recycling program with the Funding Factory. Please donate empty ink cartridges and broken or old cell phones. Place the recyclables in the designated boxes located by the main entrance to the building. The Funding Factory pays for all the necessary materials and shipping. The Funding Factory will pay GWL for each item that is sent to them. Anyone interested in helping with this program should contact Leti.
- The board would like to go forward with two fundraisers that have been suggested by members. First, is a fundraiser suggested by Maria Hoyle called An Evening of Giving at two Simon shopping malls. The other fundraiser sponsored by Kids Art was suggested by Anne Sheerin and will take place around Mother's Day.

- Linda reminded everyone that fundraisers that do not require an up-front cash outlay are great especially at this time when the SCA does not have very much cash on hand.
- Leti said that the goal for the SCA this year is to run at least one fundraiser per month.
